

Mississippi Lottery NASCAR Powerball Playoff Promotion

(Revised 1/24/2025)

RULES

1. **NO PURCHASE REQUIRED:** There is no purchase necessary to win; purchasing Mississippi Lottery products does not increase the chance of winning. Limit one entry per person, per drawing. Duplicate entries using multiple email addresses or any other method will be disqualified.

2. **WHO CAN ENTER:** The Mississippi Lottery NASCAR Powerball Playoff Promotion (Promotion) is open only to Mississippi Lottery Insiders who are natural persons who as of the date of entry (and, if a winner, as of the date of prize fulfillment) are legal residents of the State of Mississippi. Entries by out-of-state residents are void. Lottery employees, retailers and vendors, and their immediate family members residing in their household, are not eligible to win any Mississippi Lottery promotional prizes.

Entries selected in this promotion will be forwarded to the Multi-State Lottery Association and will be included in a series of drawings from entries gathered from all lotteries participating in the national NASCAR Powerball Playoff Promotion.

3. **ENTRIES:** Mississippi Lottery Insiders will receive access to an entry form by email.

Each 2025 Powerball NASCAR promotion drawing will have a unique entry form, and entrants are encouraged to submit entries for each drawing. Each submitted entry is valid for the specific drawing only; entry forms from previous drawings do not carry forward.

Each entry form will include a list of prizes available for the specific drawing. Winners from previous drawings are ineligible to win again in the Promotion

4. **DRAWING METHOD:** Promotion winners will be chosen by random drawing.

5. **ODDS OF WINNING:** The odds of winning a prize via the Promotion are based on the total number of entries for each drawing.

6. **PRIZE ALLOCATION:** Each selected entrant in the Mississippi Lottery NASCAR Powerball Playoff Promotion will receive entry into the national NASCAR Powerball Playoff, as well as a cash prize from the Mississippi Lottery.

7. **DRAWING PROCEDURE:** The pool of entries for each drawing is comprised of completed entries received based on the table below. Additionally, each selected entrant will be awarded the cash prize corresponding to the draw. These cash prizes are awarded by the Mississippi Lottery. As an incentive, selected

entries in the first five drawings will be awarded an additional “Early Bird” Bonus.

Entrants selected in each drawing are required to submit a completed claim form and execute a publicity authorization and any other required documentation in order to receive a cash prize and to be entered in the NASCAR Powerball Playoff.

Progressing through levels of the NASCAR Powerball Playoff as conducted by the Multi-State Lottery Association may qualify an entrant for additional prizes through the NASCAR Powerball Playoff. Prizes awarded by the Mississippi Lottery are limited to a maximum of one per person for the duration of the Qualifying Race portion of the Promotion. Once an entry is selected and qualified for submission into the NASCAR Powerball Playoff, subsequent entries by the player are disqualified. 8. CONTACTING WINNERS: Each winning Promotion entrant will be notified by certified mail. If the Mississippi Lottery does not receive a winner claim form from the winning entrant within 10 days of the Mississippi Lottery receiving confirmation of the certified mail delivery, such winning entrant shall be disqualified and the Mississippi Lottery, at its discretion, may randomly choose another qualified entrant to receive the prize from the same pool of entries.

9. WINNER REQUIREMENTS: Each Promotion winner will be required to submit proper identification and complete a winner claim form – the same process used for prize claims for Mississippi Lottery games. Claims made whether in person or by mail must be received by the Mississippi Lottery within the prize claim period specified in Section 8 above. The name and physical address on the entry, claim form and identification must match. The Mississippi Lottery is not responsible for lost or stolen mail, and claims received after the deadline will be rejected.

MUSL plans to publicize national semi-finalists' names in the NASCAR Powerball Playoff. Promotion winners selected by the Mississippi Lottery to participate in the NASCAR Powerball Playoff will be required to sign a release form authorizing MUSL and the Mississippi Lottery to publicize the participant's name if chosen as a national semi-finalist. **Failure to sign the release form authorizing such publicity will result in forfeiture of all aspects of the Promotion winner's prize, and the Mississippi Lottery, at its discretion, may randomly choose another qualified entrant to receive the prize from the same pool of entries.**

10. WINNERS LIST: The Mississippi Lottery will maintain a list of Promotion winners and may publicize the winners' hometowns or home counties on the Mississippi Lottery website, via social media or other means.

11. NO PRIZE EXCHANGE: All Promotion prizes will be awarded as described. No substitutions.

12. CONTEST ENTRIES AND PRIZE LIMITATIONS: Limit of one entry per person/email address for each drawing. Limit of one prize per household within the Promotion.

Entries generated by script, macro or other automated means which subvert the entry process are void. If it is discovered an entrant has submitted, attempted to enter, or used multiple accounts to enter more than the stated limit, all Promotion submissions for the entrant will be disqualified, and the entrant may be barred from future promotions, at the sole discretion of the Mississippi Lottery. All entries become the property of the Mississippi Lottery and will not be

acknowledged or returned.

13. TAXES: All federal, state, and local taxes on the total prize value, if applicable, are the responsibility of the winner. The MLC will withhold and deposit the initial state and federal taxes on behalf of the winner, as required by law. An IRS Form W-2G/1099 will be issued to the winner if required by law.

14. RELEASE OF LIABILITY: All entrants in the Promotion agree the Mississippi Lottery shall have no liability for any personal injuries, death, property damage, or other damage or expenses resulting from or arising out of any aspect of use or acceptance of the Promotion prize and participation in the NASCAR Powerball Playoff.

16. DISPUTE RESOLUTION: The venue for any dispute arising under and/or as a result of the Promotion shall be the appropriate court in Rankin County, Mississippi.
